
The Director stated that the advisory council meeting took place on August 11th. The teachers invited their advisory council to lunch then discussed ways to improve the programs.


The Director stated that the auditor came in on August 11th and began the yearly audit. He was at the school for one day doing field work and would return at a later date to finish up.
