Mr. Augustine opened the floor for nominations for Vice Chairperson. Mrs. Young nominated Ms. Hughes with a second by Mr. Reuis. Mrs. Young made a motion to elect Ms. Hughes by acclamation with a second by Mrs. Broomfield.

Mr. Augustine opened the floor for nominations for Board Secretary. Ms. Hughes nominated Mrs. Broomfield for Board Secretary with a second by Mr. Reuis. Mrs. Young made a motion to elect Mrs. Broomfield by acclamation with a second by Ms. Hughes.

Mrs. Broomfield made a motion to approve the second reading of DDA (Change to remove individual districts 29 & 19 and to add consolidated district 48). Mr. Reuis seconded the motion. The motion carried.

Mrs. Young made a motion to approve the second reading of the 2022/2023 Budget. Mrs. Broomfield seconded the motion. The motion carried.

The Director stated that he and Mr. Fischer took the building construction students to Pineview Buildings in Blackville to tour their facility and meet with their site manager. He stated that it was a beneficial trip because it allowed the students to see the process of building the storage sheds and how they progressed through the assembly line. He stated that the students were very engaged and one student that may possibly be employed there after graduation.

The Director stated that on May 13th Mr. Fulmer took his 2nd year welding students to Florence Darlington Technical College to take the AWS Certification test. He stated that nine students took the test and are currently waiting to hear the results.

The Director stated that on May 16th the Career Center held their completers ceremonies at 8AM and noon. He stated that there was a total of 90 completers.

The Director stated that <u>Swill Swiss</u> Krono has opened up their apprenticeship application again and will be conducting interview very soon to determine who will be the newest youth apprentices.

The Director stated that SRNS is also opening up a new apprenticeship position as a record management clerk. He stated that the students in the Business Education class would be the target for this position.

The Director stated that the Summer Camp will be held on July 25th – July 27th. He stated that there are 60 slots available.

Mr. Reuis made a motion to accept the financial reports as information only. Ms. Hughes seconded the motion. The motion carried.

Mr. Reuis made a motion to enter Executive Session to discuss the Director's evaluation. Mrs. Broomfield made a second. The motion carried. The board entered Executive Session at 6:30.
