**Mrs. Huggins called the meeting to order.**

**Mr. Augustine gave the invocation and led the Pledge of Allegiance.**

**The Director advised the Board that the media had been given notice of the meeting in compliance with the freedom of information act and a notice had been posted at the Center.**

**Mrs. Young made a motion to approve the agenda as presented. Mrs. Broomfield made a second. The motion carried.**

**There were no comments from the public.**

**Mrs. Young made a motion to approve the minutes of the March 28, 2022 meeting as presented. Ms. Hughes made a second. The motion carried.**

**The Director presented the Budget for the FY 2022/2023 school year. He gave updates from the State Department of Education on the Governor's new spending plan and how it will affect the Career Center. Ms. Hughes made a motion to approve the 1<sup>st</sup> Budget Reading for 2022-2023. Mrs. Young made a second. The motion carried.**

**Mrs. Smith made a motion to approve the Senior Community Service Employment Program pending that background checks and TB tests are added as requirements. Mrs. Broomfield made a second. The motion carried.**

**Mrs. Broomfield made a motion to approve the FFA Summer Camp, State Convention and National Convention trips. Mrs. Smith made a second. The motion passed.**

Mr. Augustine stated that the Criminal Justice Instructor will not be renewing his contract for the 2022-2023 year. He stated that he hates to lose the instructor. This was taken as information only and no action was needed.

Ms. Hughes made a motion to accept the Financial Report as information only. Mrs. Young made a second. The motion carried.

The Director stated that Spring Break was held the week of April 11-15, 2022.

The Director stated that BCCC and Barnwell District 45 met on April 7, 2022 to discuss an IT apprenticeship opportunity for Barnwell 45 students taking Cyber Security at BCCC. He stated that Barnwell 45 is looking at adding some youth apprenticeships with their IT program on campus. Williston District 29 currently runs this program successfully.

The Director stated that all of the instructors have now received the Z-Space training for the virtual software.


The Director stated that new cameras have been installed and were paid for through ESSER money. He stated that the cameras are now digital, have a much clearer image and had added coverage around the BCCC campus.


The Director stated that a new floor scrubber was also purchased with ESSER money. He stated that the current scrubber was very old and the new scrubber will clean the floors better and help scrub the wax off when it is time to re-wax the floors.

The Director stated that BCCC has received a grant to fund the Summer Camp this upcoming Summer. The grant is a South Carolina Office of Rural Health grant that will allow the teachers to be paid to teach the programs and fund the supplies needed. He stated that the classes that will be offered are Agriculture, Marketing, Cyber Security, Drafting, Health Science, and Auto Tech.

The next regular schedule Board meeting was scheduled for Monday, May 16, 2022 at 6:00pm. The meeting will be conducted in person unless a change is needed. The Director stated that a special called meeting needed to be held to discuss personnel matters. A virtual meeting was set for Tuesday May 3, 2022 at 6PM.
