Mrs. Huggins made a motion to accept the resignation of Employee A. Mrs. Hughes made a second. The motion carried.


Mr. Brown made a motion to accept the recommendation of the Director to hire Employee B as the Welding Instructor. Mr. Deloach made a second. The motion carried.
