The Barnwell County Career Center Board met on May 17, 2021 at 6:00pm but a quorum was not present. Mrs. Huggins called a Special Called Meeting on May 19, 2021 where a quorum was present.

Mrs. Huggins called the meeting to order.

Mr. Augustine gave the invocation and led the Pledge of Allegiance.

The Director advised the Board that the media had been given notice of the meeting in compliance with the freedom of information act and a notice had been posted at the Center.

Mrs. Patrick made a motion to approve the agenda as presented. Mr. Reuis made a second. The motion carried.

There were no comments from the public.

Mrs. Patrick made a motion to approve the minutes of the April 26, 2021 meeting with any corrections. Mrs. Broomfield made a second. The motion carried.

Before Board Officer Elections were conducted, Mr. Augustine declared the Board without officers. He stated that a Chairperson, Vice Chairperson, and a Secretary would need to be elected. He opened the floor for nominations for Chairperson.

Mr. Augustine opened the floor for nominations for Chairperson. Mr. Reuis nominated Mrs. Huggins for Chairman of the Board with a second by Mrs. Smith. With no other

nominations, Mr. Reuis made a motion to elect Mrs. Huggins by acclamation with a second by Mrs. Smith. Mrs. Smith was elected by acclamation.

Mr. Augustine opened the floor for nominations for Vice Chairperson. Mrs. Huggins nominated Mr. Reuis for Vice-Chairperson of the Board with a second by Mrs. Smith. Mrs. Patrick nominated Mrs. Hughes for Vice-Chairperson of the Board with a second by Mrs. Broomfield. With no other nominations, a vote was taken by paper ballot. The results were three to two in Mrs. Hughes favor. Mrs. Huggins did not vote.

Mr. Augustine opened the floor for nominations for Secretary. Mrs. Huggins nominated Mr. Reuis for Secretary of the Board with no second. Ms. Hughes nominated Mrs. Broomfield as Secretary of the Board with a second by Mrs. Patrick. With no other nominations, Ms. Hughes made a motion to elect Mrs. Broomfield by acclamation. Mrs. Patrick made a second. Mrs. Broomfield was elected by acclamation.

Ms. Hughes made a motion to approve the Agriculture Mechanic and Technology Course as the new program for the 2021-2022 School Year. Mrs. Patrick seconded the motion. The motion carried.

Mrs. Smith made a motion to approve the SC FFA Summer Camp 2021. Mrs. Broomfield seconded the motion. The motion carried.

Mr. Reuis made a motion to approve the trip to the 93rd Annual FFA Convention in Indianapolis. Ms. Hughes seconded the motion. The motion carried.

Ms. Hughes made a motion to approve the first reading of the EBCB Safety Plan. Mr. Reuis seconded the motion. The motion carried.

Ms. Hughes made a motion to approve the second reading of the 2021-2022 Budget. Mrs. Broomfield seconded the motion. The motion carried.

Mrs. Broomfield made a motion to approve the Financial Report as information with a second by Mr. Reuis. The motion carried.

The Director stated that on May 3rd he met with the local high school principals to discuss the bell schedule for the 2021-2022 school year.

The Director stated that on May 7th he and Mr. Still visited the Aiken County Career Center to meet with their Mechatronics teacher and tour their Mechatronics lab.

The Director stated that during the week of May 10th he met with the teachers to discuss their programs and get their ideas of how to make them better.

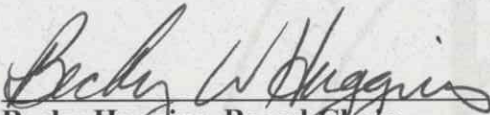
Mr. Reuis made a motion to go into Executive Session. Ms. Hughes made a second. The motion passed. The Board went into Executive Session at 7:16 PM.

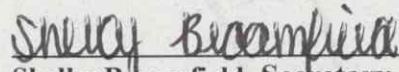
