**Mrs. Huggins called the meeting to order.**

**Mr. Augustine gave the invocation and led the Pledge of Allegiance.**

**The Director advised the Board that the media had been given notice of the meeting in compliance with the freedom of information act and a notice had been posted at the Center.**

**Mr. Reuis made a motion to approve the agenda as presented. Mrs. Young made a second. The motion carried.**

**There were no comments from the public.**

**Ms. Hughes made a motion to approve the minutes of the November 29, 2021 meeting as presented. Mrs. Broomfield made a second. The motion carried.**

**Mr. Augustine stated that January is School Board Appreciation Month. He read a proclamation from Governor McMasters. He then presented Ms. Hughes with a certificate and pin recognizing her for twenty years of service on the Barnwell County Career Center Board.**

**Mrs. Young made a motion to approve the request to take the FFA students to the FFA State Wildlife Competition. Mrs. Broomfield seconded the motion. The motion carried.**

**Ms. Hughes made a motion to approve the request to take the FFA students to the Greenhouse FFA Camp on February 17<sup>th</sup> – 20<sup>th</sup> as requested. Mrs. Smith seconded the motion. The motion carried.**

Ms. Hughes made a motion to approve the first reading of GCC-R COVID-19 Related Leave (Staff) and to add provisions for the following:

- Add language so the CDC Guidelines would be followed
- Add language stating that a doctor's excuse would need to be turned in for the absents

Mrs. Young seconded the motion. The motion carried.

Mr. Reuis made a motion to accept the Financial Report as information only. Mrs. Smith made a second. The motion carried.

The Director stated that on November 29<sup>th</sup> he attended the Denmark Tech Apprenticeship Recognition Ceremony where Denmark Tech shared information about some of the new directions they are moving towards. Denmark Tech had a former student speak about their opportunities and accomplishments they have had since graduation.

The Director stated that on December 7, 2021 all of the superintendents in Barnwell County met at the Barnwell School District 45 office to discuss the calendar for the 2022-2023 school year.

The Director stated that many of the teachers went through the bus driver training in December. The teachers must have taken a course given by the State Department of Education Bus Office in order to drive the minibus. This allows the teachers who went through the training to be able to take the students on field trips to various places.


The Director stated that the new Agriculture classes began on January 11<sup>th</sup>. There are a total of 27 students enrolled among the three courses.


