Mrs. Hogarth made a motion to approve the first reading of the update to Policy GCC/GDC. Ms. Melton made a second. The motion carried.


Mrs. Hughes made a motion to approve the 3rd Reading of the FY 2018-2019 Budget. Mrs. Huggins made a second. The motion carried.
