**The Barnwell County Career Center Board met virtually through FreeConference.com on May 18, 2020 at 6:00pm.**

**Mrs. Huggins called the meeting to order.**

**Mr. Augustine gave the invocation.**

**The Director advised the Board that the media had been given notice of the meeting in compliance with the freedom of information act and a notice had been posted at the Center.**

**Mrs. Burnette made a motion to approve the agenda. Mrs. Faust made a second. The motion carried.**

**The minutes from the April 20, 2020 meeting were reviewed. A motion to approve the minutes was made by Mrs. Burnette with a second by Mrs. Faust. The motion carried.**

**The Board was declared without officers.**

**Mr. Augustine opened the floor for nominations for Chair of the Board. Mrs. Burnette nominated Mrs. Huggins with a second by Mr. Reuis. Mrs. Faust made a motion to elect Mrs. Huggins by acclamation with a second by Mrs. Burnette. The motion carried. Mrs. Huggins was elected as Chair.**

**Mr. Augustine opened the floor for nominations for the Vice Chair. Mrs. Huggins nominated Mrs. Burnette. Mrs. Faust nominated Mrs. Hughes. Because the meeting was being held virtually, the votes were cast by texting the vote to Mrs. Hutto. By a vote of 3-1, Mrs. Burnette was elected as Vice Chair.**

Mr. Augustine opened the floor for nominations for Secretary. Mrs. Huggins nominated Mrs. Hughes with a second by Mrs. Burnette. Mr. Reuis made a motion that Mr. Hughes be elected by acclamation with a second by Mrs. Huggins. The motion carried. Mrs. Hughes was elected as Secretary.

Mrs. Burnette made a motion to amend the proposed 2nd Reading of the FY 2020-2021 budget to remove line item 100-231-112-0000-01 Board Stipend from the budget. Mrs. Huggins made a second. The motion carried with Mrs. Faust abstaining.

Mr. Reuis made a motion to approve the proposed 2nd Reading of the FY 2020-2021 budget with the approved amendment. Mrs. Burnette made a second. The motion carried with Mrs. Faust voting yes with the exception of the amendment.

Mrs. Faust made a motion to approve the 2nd and final reading of the Board Policy BE - Board Meetings. Mrs. Burnette made a second. The motion carried.

Mrs. Burnette made a motion to approve the Financial report as information with a second by Mrs. Faust. The motion carried.

Mrs. Burnette made a motion to enter into Executive Session to discuss the Director's Evaluation. Mrs. Faust made a second. The motion carried.


Mrs. Faust made a motion to adjourn from Executive Session. Mrs. Burnette made a second. The motion carried.


