Mrs. Hughes made a motion to approve the Financial report as information with a second by Mrs. Burnette. The motion carried.


Mrs. Burnette made a motion to enter into Executive Session to discuss the Director's Evaluation. Mrs. Faust made a second. The motion carried.


Mrs. Faust made a motion to adjourn from Executive Session. Mr. Reius made a second. The motion carried.
