Mr. Augustine gave the invocation and led the Pledge of Allegiance.

The Director informed the Board that he had the opportunity to visit Zeus in Aiken, SC. He stated the manufacturing facility creates medical tubing. He stated that they do not currently have interns, but they are not averse to it.

The Director informed the Board that the second year drafting students did a site walk field trip for a project in Orangeburg and also took a tour to Orangeburg-Calhoun Technical College on February 8, 2023. He stated that O-C Tech has donated some computers for the drafting program.




